PROJECT APPROVAL CHECKLIST

The applicant shall submit the Project Approval Application to the Town for review.
At a minimum, the project application shall include:
payment of all applicable fees resulting from the application;
approval from the Southwest Utah Public Health Department for the wastewater system;
estimated water demand for the development (EDU's, acre feet, gallons per month, etc.);
current zoning of the property;
a plot plan or record of survey showing proposed:
structures or buildings;
parking with dimensions of each stall or of total parking area;
setbacks to the property line and from other structures or buildings;
roads, easements or alleys;
utility lines (water, wastewater, power, gas, fiber, etc.); and
landscaping or open space, if applicable.
copy of master tax roll record to prove no back taxes are owed;
After the building permit is approved by the Town, the applicant shall submit the building permit application to the office of the Garfield County Building Official.
